Health and Wellness Terms and Conditions (please read carefully and save as reference)

The Health and Wellness expo is a not-for profit event presented by the Gulfport Senior Center Foundation. All matters not covered in these conditions are subject to the program management.

Waiting Lines: Exhibitors are responsible for lines forming outside their booth space that impede neighboring Exhibitor's ability to conduct business. Violating Exhibitors may be charged for an additional booth space.

Terms of Payment: Full payment is due by February 17, 2017. Lack of payment constitutes a cancellation of the Agreement and the Foundation reserves the right to resell the booth space. A \$25 fee will be applied for returned checks.

Exhibitor Cancellation: Requests for cancellation and refunds must be in writing. A refund on the amount paid is available to the Exhibitors who have notified the Foundation of cancellation in writing postmarked by February 16, 2017. Exhibitor cancellation after February 16, 2017 is subject to a \$150 cancellation fee. No requests will be granted after February 17, 2017.

Subletting or Sharing of booth space: Subletting or sharing of booth space or using assigned space to display equipment or materials other than those of the exhibiting is prohibited.

Booth Staffing: A maximum of four exhibit staff are allowed in a space. At least 1 of those persons must remain in the booth at all times.

Theft: The Foundation or anyone involved in the Expo are not responsible for materials and items left in your booth.

Attendance Disclaimer: The projected number of attendees expected to participate at the Expo is not guaranteed. It is based on the attendance at previous expos. While the seminars and other activities will be promoted in advance and on-site at the Expo, the Expo management are not responsible for low or no attendance at your seminar or activity.

Liability and Indemnification: Exhibitor agrees that the Expo management or the Foundation or their respective officers, directors, employees and/or agents (hereinafter "Indemnities") are not responsible for loss or damage to any property of the Exhibitor, in storage, in transit, to and from, and within the confines of the Casino.
